The Constitution of the (General) Anthroposophical Society

3rd. Conference: What Might Arise? February 23–25, 2024

To the third conference:

After we looked back at the founding of the Anthroposophical Society in the first conference and looked at its development since then in the second conference, we want to focus on the pressing questions today in this third conference:

- How can Rudolf Steiner's founding and forming impulse be adequately understood, implemented and further developed today?
- How can a meaningful constitution arise from Society, School of Spiritual Science and our legal-economic responsibilities?
- What kind of society does the Anthroposophical Movement need and do we all need today and what kind of society are future generations looking for?
- How can a space for the meaningful development of these future impulses be created within the Anthroposophical Society right now?
- What does our time demand?

On behalf of the preparatory team, I would like to warmly invite you to a joint, open and trusting reflection and discussion about these questions.

About this series of conferences:

At Christmas 2023, the Anthroposophical Society entered its second century.

To facilitate self-knowledge and further development as a society, as well as in preparing our next steps, it is necessary to transform what has so far been neglected and unresolved. In this way, the path into the future may become unencumbered and powerful. This applies above all to the tragic events surrounding the constitution of the Anthroposophical Society, which continue to have an impact to the present day.

At Christmas 1923/24, Rudolf Steiner re-founded the Anthroposophical Society. Through his preparation and guidance, a unique process of incarnation took place, which transformed the spiritual as well as the earthly (social) world in a hitherto unknown way.

This is the foundation on which we stand today as members of the Anthroposophical Society. That is our common understanding. But the reality is different. During the Christmas conference, Rudolf Steiner pointed out that the constitution had not yet been completed. In particular, his attempts to "form the appropriate relationship with the Association of the Goetheanum" (the so-called Bauverein; GA 260, p. 110), were not fully completed during his lifetime.

The decisions taken after his death to implement this appropriate relationship resulted in the Society founded at Christmas 1923 being absorbed by the (legal) body of the former Association of the Goetheanum from 1925 onwards, within which it continued to live henceforth. The statutes passed at the Christmas conference together with Rudolf Steiner were thus replaced by the Goetheanum Association statutes. The sad history of subsequent general meetings expresses this unresolved situation year after year. And what does this mean for today's Anthroposophical Society? How can we comprehend such a wound – and how can we heal it?

The open working group on the constitution question, initiated by the Section for Social Sciences under the auspices of the board of the General Anthroposophical Society (AAG) and the Anthroposophical Society in Germany (AGiD), has largely completed the work it began in 2019. In its report are documented the events that have been suppressed for such a long time.

Now we invite all members interested in an earnest striving for knowledge to an open, common exchange: What does this outcome mean for our society – today and tomorrow? How can we come to terms with what happened? How might it be healed? And how can we, commensurate with Rudolf Steiner's original intentions, make our society fit for the future from a spiritual, legal and economic point of view?
